Dear Village of Marvin Voters,

The Marvin Council adopted amendments to the Village Charter which equate to changes to our Village 'Constitution'. Thankfully, any change adopted to the Charter is subject to a referendum petition...

- We were taken aback to learn this Council rushed through impactful changes to our 'Constitution', during a national pandemic, without sincere efforts to gather public input or provide substantive information.
- The amendments would: (a) allow the Mayor to vote on all matters and (b) change our current form of government to a Manager-Council form of government.
