

REFERENDUM PETITION ADDRESSED TO THE GOVERNING COUNCIL OF THE VILLAGE OF MARVIN

Located at 10004 New Town Road, Village of Marvin, North Carolina 28173

WE, THE UNDERSIGNED, being qualified voters and citizens, residing in the Village of Marvin, North Carolina, seek the attention of the Village of Marvin Council to the people’s petition for a referendum on the matter of the Council’s amendment to our Village of Marvin City Charter,

WHEREAS, the Marvin Village Council adopted an ordinance, so named, ‘AN ORDINANCE AMENDING THE VILLAGE OF MARVIN CHARTER TO ALLOW THE MAYOR TO VOTE ON ALL MATTERS’, in accordance with N.C.G.S. §§160A-101, 160A-102 & 160A-103, and

WHEREAS, the ordinance hereinbefore named, seeks to amend Chapter III, Sec. 3-4, of the Marvin Charter, to allow the Mayor the right to vote on all matters before the Council, pursuant to N.C.G.S. §160A-101(8), and

WHEREAS, N.C.G.S. §160A-103, states any such ordinance, amending our Village of Marvin Charter “adopted in accordance with N.C.G.S. 160A-102, that is *not* made effective upon approval by a vote of the people, shall be subject to a referendum petition”, and

WHEREAS, N.C.G.S. §160A-103, further states “upon receipt of a referendum petition bearing the signatures and residence addresses of a number of qualified voters of the city” (equal to at least 10 percent) “the council shall submit the ordinance, adopted under G.S. 160A-102, to a vote of the people” and fix a special election, pursuant to N.C.G.S. 163A-1592.

THEREFORE, BE IT RESOLVED, THAT WE THE PEOPLE OF MARVIN, being qualified voters of the Village, have hereunto set our hand to this petition for a referendum, in accordance with N.C.G.S. §160A-103 and the laws of our state, to solemnly entreat the Village of Marvin Council to subject ‘AN ORDINANCE AMENDING THE VILLAGE OF MARVIN CHARTER TO ALLOW THE MAYOR TO VOTE ON ALL MATTERS’, to a vote of the people.
