

CHARTER AMENDMENT PETITION (NCGS §160A-104, and §160A-103, to the extent applicable)

WE, THE UNDERSIGNED, being qualified registered voters of the Village of Marvin, hereby petition the Village Council for a referendum election on whether or not to adopt amendments to the Village Charter, as briefly, yet completely described herein with reference to pertinent provisions of GS §160A-101.

WHEREAS, the Marvin Village Council adopted an ordinance, so named, ‘AN ORDINANCE AMENDING THE CHARTER OF THE VILLAGE OF MARVIN TO CHANGE FORM OF GOVERNMENT TO COUNCIL-MANAGER’ in accordance with N.C.G.S. §§160A-101(9), and

WHEREAS, the Marvin Village Council adopted an ordinance, so named, ‘AN ORDINANCE AMENDING THE CHARTER OF THE VILLAGE OF MARVIN TO ALLOW THE MAYOR TO VOTE ON ALL MATTERS’ in accordance with N.C.G.S. §§160A-101(8), and

WHEREAS, N.C.G.S. §160A-103, states any such ordinance, amending our Village of Marvin Charter “adopted in accordance with N.C.G.S. 160A-102, that is *not* made effective upon approval by a vote of the people, shall be subject to a referendum petition”, and

WHEREAS, N.C.G.S. §160A-103, further states “upon receipt of a referendum petition bearing the signatures and residence addresses of a number of qualified voters of the city” (equal to at least 10 percent) “the council shall submit said ordinances, adopted under G.S. 160A-102, to a vote of the people” and fix a special election, pursuant to N.C.G.S. 163A-1592.

THEREFORE, BE IT RESOLVED, THAT WE, THE QUALIFIED VOTERS OF MARVIN, hereunto set our hand to this petition for a referendum, in accordance with all applicable provisions of G.S. §160A-102 through §160A-104, in order to subject the Charter Amendment ordinances herein named, to a vote of the people.
